ORDER

As per paper read(1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2018-19 from the colleges for courses affiliated to this University. The Principal, KMCT Ayurveda Medical College, Kozhikkode-AM005 has submitted application for the continuation of provisional affiliation for the year 2018-19 vide paper read(2) above.

On verification of the application, it is found that the college has submitted the necessary documents and remitted an amount of Rs.50,000/-(Rupees Fifty Thousand Only) towards the fee for the continuation of provisional affiliation. As per paper read(3) above, Provisional Affiliation has been granted to KMCT Ayurveda College for enhancement of seats of UG(BAMS) course from 50 to 60 for the academic year 2017-18. As per paper read(4) above, the report of inspection commission submitted was scrutinized by the scrutiny committee. The Scrutiny Committee vide paper read(5) above, recommended to grant continuation of provisional affiliation for conducting BAMS course for the academic year 2018-19. The Governing Council vide paper read(6) above, has decided to grant continuation of provisional affiliation to KMCT Ayurveda Medical College, Kozhikkode for conducting BAMS course for the academic year 2018-19. The Ministry of Ayush vide paper read(7) & (8) above, granted permission to KMCT Ayurveda Medical College, Kozhikkode for conducting UG(BAMS) course with 60 seats under Section 13A of the IMCC Act 1970 from the academic session 2016-17 to academic session 2018-19.

Sanction, has therefore been accorded by the Hon'ble Vice Chancellor for implementing the decision no.44.44 of the Governing Council to grant Continuation of Provisional Affiliation to KMCT Ayurveda Medical College, Kozhikkode-AM005 for conducting UG(BAMS) course with an annual intake of 60 seats during the academic year 2018-19 subject to the conditions detailed below:-

1. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
3. Affiliation granted is strictly provisional and only for the academic year 2018-19. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
4. The College should remit annual administration fee fixed for UG course for the academic year 2018-19.
5. Admission to the next academic year shall be made only after obtaining prior permission from the University.
